UMFPL Electronics Borrowing Agreement

Borrower Requirements:

- Must be 18 years old or older
- Must present proof of a valid library account and a current photo ID at the time of checkout
- Must have their current address on file and no more than \$30.00 of outstanding account charges
- Must not attempt to alter the software or settings of the device
- Must read and sign this agreement at the Information Desk in the presence of an Information Desk staff person every
 time an electronic device is checked out

Borrowing Terms

- Items must be checked-out on the library card of the patron signing this Electronic Borrowing Agreement
- Borrowing terms vary: Devices in the Electronics Collection have a 21-day loan period.
- The device *must* be checked out from and returned to the Upper Moreland Free Public Library **Information Desk**.
 - ◆ DO NOT RETURN TO ANY OTHER LIBRARY ◆ DO NOT RETURN IN A BOOK DROP
- Device settings and software may not be altered
- As with all electronic devices, use care when handling
- As a courtesy to other borrowers, return devices fully charged

Fees and Liability

- A \$5.00 Late Return Fee will be charged to the borrowers account every day an item is kept past the due date (electronics are exempt from UMFPL's fine-free policy. Charge listed as 'local use' in borrower's account.)
- A \$25.00 fee will be charged to the borrower's account if the device is returned in a book drop or to another library
- The borrower accepts full responsibility for the device while in possession, including financial liability and costs associated with damage or loss of the device and/or peripherals due to neglect or abuse. The replacement costs: eReader: \$250 / Roku: \$50 / Audible iPod Touch: \$220 / T-Mobile HotSpot: \$100

Electronics Borrowing Agreement

- To abide by the Upper Moreland Free Public Library requirements and borrowing terms as stated above
- To accept full responsibility, including financial liability, for the device while in my possession
- That failure to return will result in legal action by local authorities: Warning: In accordance with the Library Theft Act, Section 6708 of Title 18, Pennsylvania Code (18 PA CSA § 6708) makes it a summary offense to retain library property after being notified to return it and will result in legal action by local authorities
- That the Library may use any appropriate means to collect the amount owed for fees, damage, loss or theft.
- · Not to tamper with the device, accessories, or settings
- · That failure to comply with any of these rules and guidelines will result in the loss of borrowing privileges for electronic devices

T-Mobile Acceptable Use Policy

The Services are made available provided that you also comply with the following Conditions, which are a fundamental part of this Agreement between you and UMFPL:

The Services are not used for anything unlawful, immoral or improper;

The Services are not used to make offensive or nuisance communications in whatever form, or to make or receive reverse charge calls;

The Services are only used with Equipment approved for use with the T-Mobile Network and all relevant laws and rules are followed;

The Services are not used to send, receive, upload, download or otherwise facilitate any material which is offensive, indecent, defamatory, of a menacing nature, a nuisance, a breach of privacy, an infringement of copyright or any other intellectual property right or otherwise unlawful;

The Services are not used to access or use Content in a way that infringes the rights of others;

The Services are not used otherwise than in accordance with UMFPL's and any other networks' policies for acceptable use, and (if appropriate) any relevant internet standards;

All reasonable instructions we give you are followed;

You comply with any fair use policy applicable to your use of the Services and if you are in breach of that policy you comply with any reasonable instructions that we issue to you to enable you to remedy that breach and to continue to use the Services;

You must not operate, whether directly or through a third party, any device to route or re-route voice, data or other Services on, from or to the T-Mobile Network, including but not limited to:
(i) A GSM Gateway, commonly known as a 'SIM box';

You must not sell or attempt to sell or otherwise provide commercial services using our Network to any third party without our express prior written consent;

Any information you give to us, on which we may rely in making decisions concerning the provision of Services under this Agreement, must be true at the time you give it;

You must not access any Age Restricted Services unless you are older than the required age. If you are allowed to access Age Restricted Services, you must not show or send content from the Age Restricted Services to anyone younger than the specified age. If you let anyone under the specified age use your Equipment, you must deactivate access to the Age Restricted Services.

Any failure to comply with any of the points above will entitle us to suspend or disconnect the SIM Card from the T-Mobile Network.
